TREASURER'S REPORT (2017) - MARK DASHKEWYTCH, TREASURER

Camp's primary cash revenues (sources) come from five areas: Donations (Cash and Capital), Grants, Camper Fees, Rentals and Special Events. Total Cash received from these sources was at \$ 2.4M during the past year as compared to a \$ 2.8M in the prior year, an decrease of approximately 14% (\$ 400K). Decreases were seen in Camper fees and Rentals (1%) (\$13K), Grants (39%) (\$ 48K) and Donations/Sponsorhsips (31%) (\$ 416K). This is the second consecutive year Grant revenue has decreased, (22% - 2016). Increases were seen in Endowments 46%, \$ 13K, and in Special Events and Projects 82%, \$ 131K. Cash disbursements during the past year were at \$ 2.4M as compared to \$ 2.5M during the prior year a decrease of 4%, \$ 100K. Increases were seen in Repairs and Maintenance, 650%, \$ 360K.

 - These ratios demonstrate the short term i.e. one year, financial strength of Camp. The
 Quick ratio would suggest that the Camp is more liquid i.e. more cash available, than
 others in this industry group.
- Days Cash Reserve

 - o 354 days in 2015
 - o 272 days in 2014
 - o 202 days in 2013
 - o 199 days in 2012
 - o 157 days in 2011

 - This number would demonstrate short and long term financial strength/risk of Camp. Having enough cash on hand provides advantages to potential donors in the sense that donors and potential donors see that the organization is low risk and will continue to provide enduring benefit for the dollars donated. Nevertheless the common industry mantra is to have 6 months or 180 days of cash reserves.
- Working Capital Ratio (Short Term Assets Short Term Liabilities) / 12 Months Expenses. Camp was
 measured using strictly cash liabilities i.e. not including deferred contributions or capital. Nationally (U.S.)
 scores greater than 1 would earn a top rating while the National average is .75 or nine months.

Summer Camp Report

2017 was another successful summer for the campers of Camp He Ho Ha. Working with the same resources, we are happy to be able to serve more individuals with special needs. Last year we increased the capacity for our campers and saw an increase in numbers for attendance. For 2017, we once again saw an increase in attendance with a total of 721 campers at our programs for 2017 compared to 711 the year before. 81 aides joined our summer camp programs this year to support the individuals that require additional care.

Consistently over the last few years we have had camper spaces remaining open in the teens and children camps (mental and physical) as well as our Seniors camp and the first camp for adults with mental disabilities. Our camps for adults with mental disabilities that are scheduled for the warmer weather fill very quickly. There were 48 spot of availability for the season in 2017. Recognizing this, we made an effort to expand our advertising for our camps directly targeting the seniors and teens and children demographic. We contacted many seniors care facilities as well as all of the schools within the Edmonton district to promote our camps. We hope that these attempts will give positive results for the 2018 season.

Summer staff were hired through February and March of 2017. We received 148 applicants for the 34 positions. With only 4 applications submitted for the grad nurse role we were lucky to hire a nurse for the summer. We began our orientation with a total of 37 staff and through orientation we lost 3 with another 4 leaving throughout the summer. Our year end banquet dinner had 30 seated at the table. With the additional work required by those remaining, we finished the summer strong and the campers had a thoroughly enjoyable experience.

RENTALS

Another year has come and gone, and Camp Health, Hope & Happiness can once again take great pride in the success of the facility rental program. Bookings for 2017 generated funds totaling over \$550,000 which accounts for approximately 25% of Camp's annual income.

With many old friends returning and new guests enjoying a first time visit, the He Ho Ha gates opened to just under 3,000 men, women, children, students and families. We continue to receive inquiries on a daily basis by way of email, the website and phone calls leading us to believe 2018 will be another successful year.

Word of mouth is, and always will be, our greatest rental resource. Satisfied customers recommend Camp He Ho Ha to friends, family and associates. Scrap booking and quilting are extremely popular activities and we have become a favorite site for these retreats.

Our customer satisfaction survey is distributed to each rental group. It remains, and always will be, an important evaluation of our work. All comments, good or bad, are taken very seriously and all valid concerns are promptly addressed.

Whether it's a day trip, a weekend retreat or an extended visit, the "He Ho Ha team" works together to ensure we maintain a level of excellence we can all be proud of and that each and every guest enjoys a rewarding and memorable stay.

GRANTS & FUNDRAISING

Another year of change has occurred. The resignation of Kelly Hobson who was responsible for grants and fundraising, created a vacancy in this department. Grant writers in Alberta are in great demand. Securing a grant writer is next to impossible. To provide assistance in this department, I am writing grants and working with donors.

CAPITAL GRANTS \$282,790

Reconciling major capital grants from the province's Community Facility Enhancement Program and from Canada's 150 Western Economic Diversification Canada was a major focus in 2017. From the province Camp received \$70, 255 to replace concrete and install new toilet stalls. From the federal government, camp received \$117,459 for the replacement of shingles on all camp buildings and concrete replacement. These grants were awarded in 2016 and had reconciliation deadlines in 2017. Additional funding for these projects came from the Edmonton Community Foundation, President's Choice Children's Charity, REALTORS® Community Foundation, The Thrift Shop St. Andrews United Church, and the Rexall Foundation. The Stollery Charitable Foundation funded a new gator to be used in maintenance.

EMPLOYMENT GRANTS \$68,982

\$51,282 in combined funding from the federal government's CANADA SUMMER JOBS and the provincial government's SUMMER TEMPORARY EMPLOYMENT PROGRAM offset wages for several summer staff. The Rexall Foundation also awarded to camp to offset summer camp wages. Additional funding was awarded by the Royal Alexandra Hospital Employee's Charitable Fund and the Allard Foundation to subsidize salaries for the nurses.

OPERATIONAL DONATIONS

Many generous donors including clubs, organizations, corporations renewed their operational support in 2017. Times are changing, and funding operational expenses for established organizations such as Camp He Ho Ha continues to be our greatest challenge. However, we continue to be optimistic that new relationships can be built, and new funding streams secured in the future. Third party events and new fund raising events will also assist with operational funding.

The majority of donations is derived from service clubs. With service clubs closing every month due to attrition, financial support from these organizations is dwindling. Camp He Ho Ha is facing a huge challenge. Alberta's challenging financial climate presents another obstacle. Nevertheless, with hard work and unwavering donors, staff and fundraiser participation, Camp's future will continue to thrive.

ANNUAL CAMPAIGN \$105,196

Despite the challenging times, the donations from the Annual campaign accounted for \$105,196 in revenue.

SHOOT FOR CAUSE \$106,644

For 22 years the Shoot For Cause has been a very successful fund raiser. Despite the challenges and Alberta's economic climate, our faithful archers rallied to raise an impressive \$106,644.

THIRD PARTY EVENTS \$56,932

Since Camp's staff resources are very limited, these third party events are extremely welcomed by Camp. These events are organized and facilitated by a group of people with little participation of Camp staff. The World Financial Group hosted a very successful weekend baseball tournament that raised \$24, 201. Another very successful third party event was the Edmonton Oilers 50/50 draw which is an exciting aspect of every home game. Camp He Ho Ha was invited to participate in this exciting fund raising event at Rogers Place. With 60 volunteers, Camp received \$23,737.50!

SUNNY SUPPORTERS \$\$4,820

This was the second time for this campaign which offered campers and their families a chance to donate. Donations of \$5 or more earned a badge on the "Wall of Fame" in the Rec Hall which quickly became a friendly reminder of how much the campers and the families support the organization. In its second year the donations were just short of doubling the previous year.

MEMORIALS \$16,810

Memorial donations are left "In Memory" of loved ones, and for Camp it is usually the loss of one of our beloved camps or a dear friend of camp.

WILLS & ESTATES \$40,806

Camp's Legacy Program was initiated encouraging individuals to donate a portion of their estate to Camp He Ho Ha which truly is camp's future sustainability.
